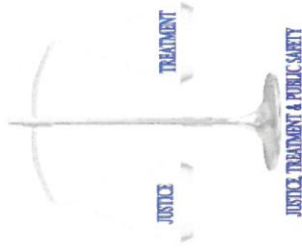


PURPOSE, GOALS AND ELIGIBILITY



Purpose

The Mental Health Court (MHC) combines judicial supervision with community based mental health services and other supportive services to provide adults with a serious and persistent mental illness, co-occurring mental health and substance use disorder and/or developmental disorder, who have committed a misdemeanor offense, as the result of mental illness, developmental disability or co-occurring disorder, with the support needed to meet both legal obligations and improve the participant's quality of life.

Program Eligibility

All participants who enter into the MHC do so voluntarily.

To be eligible to participate in the 29th District MHC you must:

- Be 18 years or older
- Reside in Wayne County
- Have a diagnosis of a Serious and Persistent Mental Illness, co-occurring Mental Illness and Substance Use Disorder, and/or Developmental Disorder
- Be charged with a misdemeanor or ordinance violation (or a felony reduced to a misdemeanor)
- Agree to complete all of the recommended treatment that is included in your sentencing.

In all cases, and regardless of the pending charge, the Prosecuting Attorney must agree to the Defendant's admission into the MHC.
