A regular meeting of the Wayne City Council was held on Tuesday, March 17, 2020, at 8:00 p.m. at the Wayne City Hall, 3355 South Wayne Road.

**03-20-0060** Motion by Webster to approve the agenda with the amendment of adding the approval of postponing the Budget Study Session previously scheduled for Tuesday, March 24, 2020 until further notice as item 6i under General Items, another motion was made before support was given to this motion.

**03-20-0061** Motion by Miller to table item 6f., until after the Budget Study Session. Motion failed due to lack of support.

O3-20-0062 Motion by Webster, seconded by Porter and carried by a 4-1 roll call vote (Miller) to approve the agenda with the amendments of "Approval of postponement of the previously scheduled FY 20-21 Budget Study Session until further notice" as item 6i. and changing item 6b. to 6b1 and adding item 6b2 as "Approval of Professional Services Agreement with TUV Rheinland Industrial Solutions, Inc.
